4.1.7		Amend clause to clarify that the protective barrier may be shipped separately from the appliance.
4.7.12, 4.9.5		Amend clauses to require the replacement of the word "LP" with "propane "on the appliance marking label. All convertible direct vent appliances will require revised markings.
4.10.1		Amend clause to allow the use of controls Certified to 60730-2-5 instead of C22.2 no.199. The use of controls Certified to 60730-2-5 is not mandatory at this time.
4.34.2j		Amend clause to require the gas designation on the appliance rating plate to be changed from "LP" to "Propane". All currently Certified products using propane gas will require revised rating plates.
5.13.3 <i>,</i> 5.13.5		Amend clauses to require that the explosion testing be repeated with the appliance in a heated condition. All direct vent appliances must be reevaluated or retested to demonstrate compliance with these provisions.
Annex I		Add Annex I, applicable to all direct vent appliances, containing consumer information intended to enhance the safer operation of the appliance. All direct vent appliances will require revised instruction manuals containing the information contained in this Annex.
