# TRADING WITH MOZAMBIQUE

**Exporters/Importers trading with Mozambique need to comply with the requirements of the Government of the Republic of Mozambique, Conformity Assessment Programme in order for their goods to clear customs. Failure to do so can result in severe delays in goods clearance, penalties or even shipments being returned.**

The Mozambique CAP was implemented by the Government of the Republic of Mozambique, represented by the National Institute of Standards and Quality (INNOQ,IP), to assure Mozambiquan consumers of the quality and safety of imported goods and to facilitate trade. 'Regulated Products' within the programme require a Certificate of Conformity (CoC) which verifies, in the respective exporting countries to meet Mozambique technical regulations and mandatory standards or approved equivalent International/National Standards.


### The requirements for CAP include:

- Every consignment of imported goods which contains regulated products must be accompanied by a CoC issued by your local Intertek Country Office prior to shipment.
- The CoC Certificate is required to ensure smooth Customs clearance of shipments in Mozambique.
- The CoC Certificate confirms that the products comply with the relevant Mozambique technical regulations and approved standards.
- The authorities in Mozambique may take random samples from imported consignments to verify compliance.
