Overview of Changes: Update No. 1 covers the revision of Clause 5.4.2.3 to specify the power supply cord length of 0.5 m (1.5 ft) to 1.8 m (6 ft) for cord-connected attic exhaust fans.

5.4.2.3		Additions to existing requirements are <u>underlined</u> below. Cord-connected equipment shall have a length of supply cord or special-use cord as follows: a) for pendant ceiling fans, not more than 1 m (3 ft); b) for commercial fans and blowers used for carpet cleaning or flood restoration and remediation, between 1.8 m (6 ft) to 7.6 m (25 ft); c) for cord-connected range hoods, as specified in Clause 5.4.2.15; d) for cord-connected air-to-air heat exchangers, not more than 1.8 m (6 ft), or for window-mounted air-to-air heat exchangers, 2.4 m (8 ft) to 3 m (10 ft); e) for cord-connected agricultural fans, 0.5 m (1.5 ft) to 3.7 m (12 ft); f) for cord-connected clothes dryer booster fans, not more than 1.8 m (6 ft); g) for cord-connected down draft fans, 0.457 mm (18 in) to 762 mm (30 in); h) for cord-connected attic exhaust fans, 0.5 m (1.5 ft) to 1.8 m (6 ft); and i) for all other equipment, between 1.8 m (6 ft) and 3 m (10 ft).
