7.12.1		Additional installation instructions for fixed towel rails are specified; The installation instructions for fixed towel rails shall include the substance of the following: WARNING: In order to avoid a hazard for very young children, this appliance should be installed so that the lowest heated rail is at least 600 mm above the floor. The instructions for fixed towel rails likely to be used in a bathroom shall state that the towel rail is to be installed so that switches and other controls cannot be touched by a person in the bath or shower. This instruction is not necessary if the towel rail is
		at least IPX4.
20	Info	Stability and mechanical hazards
20.102		 A test is added to ensure that the doors of clothes dryers can be opened from the inside; The doors of clothes dryers that contains a free space shall be capable of being opened from the inside. <i>Compliance is checked by inspection, by measurement and by the following test.</i> A force is applied to a point, equivalent to an accessible inside point, of each appropriate door of the appliance, at the midpoint of the edge farthest from the hinge axis in the direction perpendicular to the plane of the door. The force shall be applied at a rate not exceeding 15 N/s and the door shall open before the force exceeds 70 N.
20.103		A test is added to ensure that appliances with horizontally hinged doors have adequate stability when the door is subjected to a load; Appliances with horizontally hinged doors shall have adequate stability when the open door is subjected to a load. <i>Compliance is checked by the following test.</i> <i>The empty appliance is placed on a horizontal surface and a mass of 23 kg applied to the centre of the open door.</i> <i>The appliance shall not tilt.</i> NOTE Damage and deformation of doors and hinges are neglected.
