Overview of Changes: Revisions to this Standard have been made to enhance the safety of chain saws, including the following:

- New IEC, ISO, and USDA Standards are referenced, and the text of this Standard has been harmonized with International Standards where appropriate.
- Chain saw sound pressure level limits were clarified.
- The test method for longitudinal balance was modified for Class 1B and 2B saws, and harmonized with ISO 8334.
- The test method for determining the vibration level for Type 2 saws was clarified.
- Two additional chain saw marking requirements were added.
- · Various other editorial changes were made to enhance clarity of meaning throughout the Standard.
