TRADING WITH MOROCCO

Exporters/Importers trading with Morocco need to comply with the requirements of the Ministry of Industry, Trade, Green and Digital Economy (MICEVN) Verification of Conformity (VoC) Programme in order for their goods to clear customs. Failure to do so can result in severe delays in goods clearance, penalties or even shipments being returned.

The Morocco VoC was implemented to assure Moroccan consumers of the quality and safety of imported goods and to facilitate trade. 'Regulated Products' within the programme require a Certificate of Conformity (CoC) which verifies, in the respective exporting countries or locally in Morocco for some specific products, that the products comply with the applicable Moroccan technical regulations and mandatory standards or approved equivalent International/National Standards.

Regulated products include chemicals, electricals and electronics, textiles, personal protective equipment, food contact materials, automotive spare parts, building products and toys.

The requirements for VoC include:

- Every consignment of imported goods which contains regulated products must be accompanied by a CoC issued by your local Intertek Country Office prior to shipment.
- The VoC Certificate is required to ensure smooth Customs clearance of shipments in Morocco.
- The VoC Certificate confirms that the products comply with the relevant Moroccan technical regulations and approved standards.
- The authorities in Morocco may take random samples from imported consignments to verify compliance.
