

## STANDARD INFORMATION

This SUN establishes Continued Certification for currently Listed CAN/CSA C22.2 No. 60745-2-5/UL 60745-2-5 Listing Reports and introduces CAN/CSA C22.2 No. 62841-2-5/UL 62841-2-5 as the superseding standard.

**Superseded Standard:** CAN/CSA C22.2 No. 60745-2-5 / UL 60745-2-5 (CSA 4<sup>th</sup> Ed/UL 5<sup>th</sup> Ed) Hand-Held Motor-Operated Electric Tools - Safety - Part 2-5: Particular Requirements for Circular Saws

**Superseding Standard:** CAN/CSA C22.2 No. 62841-2-5 / UL 62841-2-5 (1st Ed) Electric Motor-Operated Hand-Held Tools, Transportable Tools and Lawn and Garden Machinery – Safety – Part 2-5: Particular Requirements for Hand-Held Circular Saws

## EFFECTIVE DATE OF NEW/REVISED REQUIREMENTS

**Effective Date:** **November 30, 2019**

## IMPACT, OVERVIEW, AND ACTION REQUIRED

### Impact Statement:

Review of all certified lithium-ion cordless products (i.e. the battery system and the battery charger), that have been previously evaluated to CAN/CSA-C22.2 No. 60745-2-5 / UL 60745-2-5 will be required to comply with the new requirements in the Standard for Safety for Electric Motor-Operated Hand-Held Tools, Transportable Tools and Lawn and Garden Machinery – Safety – Part 2-5: Hand-Held Circular Saws, CAN/CSA C22.2 No. 62841-2-5/UL 62841-2-5.

For Electric motor-operated hand-held tools, this new standard CAN/CSA C22.2 No. 62841-2-5 / UL 62841-2-5 coexists with the existing standard to allow the certified mains powered hand-held motor operated tools that are not impacted by the additional requirements to remain certified to the standard CAN/CSA-C22.2 No. 60745-2-5 / UL 60745-2-5 until its expected withdrawal date of February 10, 2028 (10 years after the publication of the standard CAN/CSA-C22.2 No. 62841-1 / UL 62841-1).

After **November 23, 2019**, all new product designs (corded and cordless) and revised constructions of currently certified products will be required to be evaluated in accordance with the new requirements of CAN/CSA C22.2 No. 62841-2-5 / UL 62841-2-5.
