		A non-hand-held wand-type mixer that is intended to be mechanically attached to a mixing container and is provided with an interlock switch that must be actuated only by this mechanical attachment to the container before ON operation of the appliance can occur, is not required to be provided with the momentary contact ON/OFF switch specified in 28.1. The interlock system shall comply with the interlock system requirements of 6.19.3. The mixing container may be provided with the appliance, or recommended by the manufacturer in the instructions.

65.2		New clause added; The instructions and warning statements required by 7.8, 7.9, 28.3, 63.7, 64.1, and 65.1 shall be provided as printed material. All other instructions may be provided in electronic read-only media format, such as DVD, website (accessible via URL, QR code, or similar means), flash drive or CD-ROM.
