A FPDU for a kitchen or bathroom countertop is intended for connection to a permanently-installed receptacle on a branch circuit rated 125 V AC and 20 Amperes or less. A FPDU for a kitchen or bathroom countertop is intended for mounting to either a portable or stationary furnishings only, as a power supply connection for cord and plug connected electrical utilization equipment, in accordance with the National Electrical Code, NFPA 70 (see standard for details).
